4. The Year Book in hand covers the financial year 2018-19. It elaborates the major activities carried out by this Ministry and its accomplishment made during the period.

5. Therefore, it is hoped that this book will serve as a useful reference for all readers. Comments/suggestions (if any) will be welcomed.

BRIEF OF THE MINISTRY

1 Introduction:

The Ministry of Parliamentary Affairs was established in April, 2012. Subsequently, the Prime Minister's Public Affairs and Grievances Wing was also transferred to this Ministry by Prime Minister's Office in June, 2013.

The Ministry primarily deals with the business of the Government in Parliament and supervises the entire legislative processes: such as summoning and prorogation of both the houses of the Parliament, follow up of Government Assurances given in the Parliament, legislation pertaining to functions of both the Houses. It plays an important role in coordinating and maintaining liaison amongst different organs of the State with the objective of ensuring harmonious functions of the polity. Moreover, Prime Minister's Public Affairs and Grievances Wing (PA&GW) of the Ministry is also working for redressing grievances of the common people.

1.1. Mission Statement:


The Mission Statement of the Ministry of Parliamentary Affairs is as under:

"To facilitate the legislative process of the Federal Government by ensuring that Government business in both Houses of the Parliament is disposed off effectively and Parliament function in accordance with the provisions of the Constitution and relevant Rules and Procedures relating to Government business."

1.2. Functions of Ministry of Parliamentary Affairs under Rules of Business, 1973:

Following functions have been allocated to the Ministry of Parliamentary Affairs under Rules of Business, 1973:

- Majlis-e-Shoora (Parliament), summoning of either House or both Houses or Joint Sitting of Majlis-e-Shoora (Parliament) and prorogation thereof.
- Dissolution of the National Assembly.
- Liaison between the Divisions and Majlis-e-Shoora (Parliament) in respect of official and non-official business; priority of official business.
- Follow up of the assurances, promises and undertakings given by the Federal Government on the floor of the House with a view to their implementation by the Divisions concerned.
- Submission of Bills passed by Majlis-e-Shoora (Parliament) or by the National Assembly to President for his assent.
- Legislation pertaining to privileges of Majlis-e-Shoora (Parliament) and members of Majlis-e-Shoora (Parliament), salaries and allowances of the Chairman and Deputy Chairman of the Senate, Speaker and Deputy Speaker of the National Assembly and members of Majlis-e-Shoora (Parliament).
- Legislation pertaining to the Leader of the House and the Leader of the Opposition, provision of staff and other facilities for the Leader of the House.
- Rules of Procedure of either House or Joint Sitting of Majlis-e-Shoora (Parliament).
- Legislation pertaining to punishment of persons who refuse to give evidence or produce documents before committees of National Assembly or the Senate.
- > Appointment and terms and conditions of Federal Parliamentary Secretaries.
- Legislative business relating to the Election Commission.
- Prime Minister Public Affairs / Grievances Wing.



1.3. <u>Administrative setup of the Ministry:</u>

Ministry of Parliamentary Affairs comprises of three wings namely:

- I. Administration (Admn) Wing.
- II. Legislation Wing.
- III. Public Affairs and Grievances Wing (PA&GW).

I. <u>Administration Wing:</u>

The Administration Wing is headed by a Joint Secretary (Admn), who is assisted by Deputy Secretary (Admn), three Section Officers, one Accounts Officer and one Programmer.

II. Legislation Wing:

The Legislation Wing is headed by a Joint Secretary (Legislation), who is assisted by three Deputy Secretaries, two Assistant Secretaries and one Section Officer. This is mainstay of the Ministry.

III. <u>Public Affairs and Grievances Wing:</u>

This wing is headed by a Joint Secretary, who is assisted by three Deputy Secretaries and Eight Section Officers. This is an important wing of the Ministry as this wing is providing welfare services to the common people of Public with a public friendly approach.

II. <u>LEGISLATION WING</u>

1. <u>NATIONAL ASSEMBLY SECTION ACTIVITIES:</u>

i. <u>SESSIONS OF PARLIAMENT:</u>

In terms of Article 54 (1) of the Constitution, the President summons either House or both Houses or Majlis-e-Shoora (Parliament) in joint sitting to meet at such time and place as he thinks fit and also prorogues the same.

Article 54 (2) of the Constitution provides that the National Assembly shall meet for not less than 130 working days in each parliamentary year.

During the last parliamentary year (from 13th August, 2018 to 12th August, 2019) the National Assembly met for 130 days.

ii. **PROVISIONAL CALENDAR OF SESSIONS:**

The Ministry regularly calls sessions of the two Houses for which provisional calendar of Sessions was approved in advance.

Rule-46 (1&2) of the Rules of Procedure and Conduct of Business in the National Assembly, 2007 provides: -

"After the commencement of each parliamentary year, the Government shall provide a calendar for sessions of the National Assembly to the Speaker".

The Secretary shall cause the calendar to be circulated amongst the members."

These calendars are prepared to forecast the likely engagements of the Parliamentarians in order to enable them to plan their personal / professional programme accordingly, this practice is also intended to help the Cabinet members to pre-plan their schedule of activities.

The provisional calendar of sessions for the National Assembly for the last parliamentary year was prepared in consultation with Speaker, National Assembly and after approval of the Prime Minister the same was circulated amongst the Members of Parliament **(Annex-I)**.

iii. ORDERS OF THE DAY:

Ministry of Parliamentary affairs issued eighty-six (86) Orders of the Day to transact Government Business viz: official Bills, Reports to be laid, Motions etc. in the National Assembly under rule 52 of the Rules of Procedure and Conduct of Business in the National Assembly, 2007.

iv. <u>LEGISLATION:</u>

During the year, 2018-19 twenty-one Bills were introduced (Annex-II) and nine (09) Bills were passed (Annex-III) by the National Assembly. The Parliament passed seven (07) Acts (Annex-IV).

viii. JOINT SITTING:

On 17th September, 2018, the President of the Islamic Republic of Pakistan addressed the Parliament (Joint Sitting) to meet the constitutional requirement under Article 56 (3) of the Constitution of Islamic Republic of Pakistan.

2. <u>SENATE SECTION'S ACTIVITIES:</u>

The President, under Clause (1) of Article 54 of the Constitution of Islamic Republic of Pakistan is empowered to summon either House or both Houses of Majlie-Shoora (Parliament) in joint sitting to meet at such time and place as he thinks fit and also to prorogue the same.

Article 61 read with Article 54 (2) of the Constitution provides that Senate shall meet for not less than one hundred and ten (110) working days in each Parliamentary year.

The Ministry prepared and got approved a tentative schedule of session of Senate from the Prime Minster for the period from 12th March 2018 to 11th March 2019. The summaries for summoning of Senate session were initiated strictly in accordance with approved schedule during the Parliamentary Year. However, certain deviations were made depending on the exigencies of administrative factors.

i. <u>SESSIONS:</u>

The Senate met in fourteen (14) sessions including two (02) Joint Sitting and two (02) requisitioned sessions spread over one hundred and eighteen (118) working days (Annex-VIII).

ii. ORDER OF THE DAYS:

In pursuance of rule 38 of the Rules of Business, 1973, Ministry issued sixtyeight (68) Orders of the Day in the year, 2018-19, for introduction and passage of Government legislative business in the Senate.

iii. <u>GOVERNMENT BILLS / ORDINANCES INTRODUCED:</u>

Four (04) Government Bills / Ordinances were introduced in the Senate (Annex-IX).

iv. <u>GOVERNMENT BILLS PASSED:</u>

Four (04) Government Bills were passed by the Senate (Annex-X).

In compliance with Article 73 of the Constitution, the Finance Minister tabled the Finance Bill, 2018, in the Senate for its recommendations thereon. The Senate extensively discussed the Bill and made one hundred and seventy-seven (177) recommendations for consideration of the National Assembly. The Senate also submitted the recommendations to National Assembly on four Money Bills as a whole. (Annex-XI).

v. <u>PRIVATE MEMBERS' BILLS PASSED:</u>

During the financial year, 2018-2019 nine (09) Private Members' Bills were passed by the Senate (Annex-XII).

vi. <u>CALLING ATTENTION NOTICES, ADJOURNMENT MOTIONS,</u> PRIVILEGE MOTION AND QUESTIONS:

During the year 2018-2019 two hundred and nineteen (219) Calling Attention Notices were received in the Senate, one hundred and fifty-five (155) Adjournment Motions were received and seventeen (17) Privilege Motions were received (Annex-XIII).

vii. <u>RESOLUTIONS / REPORTS:</u>
