FOREWORD

The Ministry of Parliamentary Affairs, formerly a wing of Law and Justice Division, came into existence in April, 2012 as a result of reorganization of the Federal Secretariat.



2. The Year Book of the Ministry of Parliamentary Affairs is an official hand book, compiled in pursuance of sub-rule (2) of Rule 25 of the Rules of Business, 1973 to

review activities, achievements and progress made by the Ministry during the preceding financial year and also uploaded on its website for information of the Cabinet as well as general public.

- 3. The ministry is a sole coordinating agency between the Ministries/Divisions and both Houses of the Parliament. The main functions of the ministry include summoning and Prorogation of both the houses of Parliament, providing liaison between the divisions and parliament regarding official business, following up of Government assurances given by the Federal Government and look after the matters of Prime Minister's Affairs and Grievance Wing.
- 4. The parliament represents the aspirations of the common people in decision making process. The Year Book in hand covers the financial year 2017-18. It elaborates the major activities carried out by this Ministry and the achievements made during the period under report.
- 5. Therefore, it is hoped that this book will serve as a useful reference for all concerned. Comments/Suggestions (if any) will be welcome as it will be helpful in improving the quality of this Year Book.

BRIEF OF THE MINISTRY

1 Introduction

The Ministry of Parliamentary Affairs was separated from the Ministry of Law, Justice and Parliamentary Affairs in April, 2012. Later on, the Prime Minister's Public Affairs and Grievances Wing was also transferred to this ministry by Prime Minister's Office in June, 2013.

The Ministry of Parliamentary Affairs primarily deals with the business of the Parliament and supervises the entire legislative processes: such as summoning and prorogation of both the houses of the Parliament, follow up of Government Assurances given in the Parliament, legislation pertaining to functions of both the houses. It plays an important role in coordinating and maintaining liaison among different organs of the State with the objective of ensuring harmonious functions of the polity. Additionally, Prime Minister's Public Affairs and Grievances Wing (PA&GW) of the ministry is working with the aim of redressing grievances of the common people.

1.1. <u>Mission Statement:</u>

The Mission Statement of the Ministry of Parliamentary Affairs is as under:


"To facilitate the legislative process of the Federal Government by ensuring that both Houses of the Parliament perform and function in accordance with the provisions of the Constitution and relevant Rules and Procedures."

1.2. <u>Functions of Ministry of Parliamentary Affairs under Rules of</u> Business, 1973.

The following functions have been allocated to the Ministry of Parliamentary Affairs under Rules of Business, 1973:

- Majlis-e-Shoora (Parliament), summoning of either House or both Houses or Joint Sitting of Majlis-e-Shoora (Parliament) and prorogation thereof.
- > Dissolution of the National Assembly.
- Liaison between the Divisions and Majlis-e-Shoora (Parliament) in respect of official and non-official business; priority of official business.
- Follow up of the assurances, promises and undertakings given by the Federal Government on the floor of the House with a view to their implementation by the Divisions concerned.
- Submission of Bills passed by Majlis-e-Shoora (Parliament) or by the National Assembly to President for his assent.
- Legislation pertaining to privileges of Majlis-e-Shoora (Parliament) and members of Majlis-e-Shoora (Parliament), salaries and allowances of the Chairman and Deputy Chairman of the Senate, Speaker and Deputy Speaker of the National Assembly and members of Majlis-e-Shoora (Parliament).
- ➤ Legislation pertaining to the Leader of the House and the Leader of the Opposition, provision of staff and other facilities for the Leader of the House.
- ➤ Rules of Procedure of either House or Joint Sitting of Majlis-e-Shoora (Parliament).
- ➤ Legislation pertaining to punishment of persons who refuse to give evidence or produce documents before committees of National Assembly or the Senate.
- > Appointment and terms and conditions of Federal Parliamentary Secretaries.
- Legislative business relating to the Election Commission.
- > Prime Minister Public Affairs / Grievances Wing.

1.3. Administrative setup of the Ministry

The ministry of Parliamentary Affairs comprises three wings namely:

I.Administration (Admn) Wing.

II.Legislation Wing.

III. Public Affairs and Grievances Wing (PA&GW).

I. Administration Wing:

The Administration Wing is headed by Joint Secretary (Admn), who is assisted by Deputy Secretary (Admn), three Section Officers, one Accounts Officer and one Programmer.

II. Legislation Wing:

The Legislation Wing is headed by Joint Secretary (Legislation), who is assisted by three Deputy Secretaries, two Assistant Secretaries and one Section Officer.

III. Public Affairs and Grievances Wing:

This wing is headed by Joint Secretary, who is assisted by three Deputy Secretaries and Eight Section Officers. This is an important wing of the Ministry as this wing is providing welfare services to the common people of Public with a public friendly approach.

2. Administration Wing

All administrative, financial, litigations and other connected issues of the main Ministry is dealt within the Administration Wing.

The sanctioned strength of the Ministry is as follows:

Officers (BPS 17-22)	39
Officials (BPS 1-16)	156

The activities carried out by different sections of Administration Wing during the financial Year 2017-18 are on the following paragraphs. However, details pertaining to below mentioned activities in respect of each section is attached as **Annexure-I.**

2.1. Administrative Activities:

Seven Hundred and Eleven (711) cases relating to posting, transfer, recruitment, promotion, leave on full pay, pension papers, house building allowance, seniority list of employees, and many other such cases were prepared and finalized.

2.2. Coordination Activities:

Following activities were performed:

- ➤ One Hundred and Thirty (130) cases of hiring were processed and finalized for providing residential accommodation to officers/officials of the Ministry.
- Twenty Eight (28) officers/officials were nominated for multiple trainings to enhance the capacity, skills and knowledge of the officers/officials of this ministry.
- Established Public Complaint Cell in collaboration with Federal Ombudsman Secretariat to address the Complaints of General Public.
- ➤ Compilation and publication of Year Book 2016-17.

➤ Developed Standard Operating Procedures (SOPs) for Litigation Cases and regular maintenance of dashboard to keep up-to-date list of all litigation cases.

2.3. General Activities:

All cases relating to functioning of Transport Fleet of the Ministry, purchase of stationary items, store items, furniture, R&I Section, maintenance & security of Office building/accommodation are dealt under this activity, following activities were carried out:

- Five Hundred and Seventeen (517) cases were initiated and finalized, that mainly pertains to transport, stationary and office equipment.
- ➤ Eight Thousand Nine Hundred and Forty (8940) official letters were received and Seven Hundred Six Hundred and Thirty Seven (7637) letters were issued in R&I Section.

2.4. Budget Related Activities:

Total Budgetary Allocation of the Ministry during the FY-2017-18: **Rs.395.923 Million.**

- The objective of Budget and accounts section is to maintain a high-level of financial discipline and to improve the quality of financial operations in the Ministry. It was duly endorsed in the meeting of Departmental Accounts Committee of 25th April, 2018. Moreover, it was recognized that a remarkable level of financial discipline has been maintained in the Ministry through implementation of internal controls in procurement planning, regularity in expenditure and proper documentation of all transactions.
- Monthly expenditure of the Ministry was accurately and promptly reconciled with AGPR figures. This was done in compliance of a critical requirement of CGA Organization.

3 <u>Legislation Wing</u>

3.1 <u>National Assembly Related Activities:</u>

3.1.1 Constitutional Provisions:

Ministry of Parliamentary affairs derives its legal mandate from the following provisions of the Constitution:

- The President summons either House or both Houses or Majlis-e-Shoora (Parliament) in joint Sitting to meet at such time and place as he thinks fit and also prorogue the same.

 (Article 54(1))
- The National Assembly shall not meet less than 130 working days in each Parliamentary Year.

 (Article 52(2))

3.1.2 Performance:

A brief regarding multiple activities performed during the period under report is as under, and the details are attached as **Annexure-II**.

- ➤ During the Parliamentary Year- 2017 to 2018, the National Assembly met for 152 days during the year 2017-2018.
- ➤ Prepare the provisional calendar of sessions for the National Assembly for the FY-207-18 in consultation with the Speaker, National Assembly and circulated the same amongst the members of the Parliament after getting approval of the Prime Minister.
- ➤ Issue Ninety-Five (95) Orders of the days to transact Government Business in the National Assembly in terms of Rule 52 of the Rules of Procedure and Conduct of Business in the National Assembly, 2007.
- Thirty six (36) bills were introduced, and forty seven (47) bills were passed by the National Assembly. The parliament passed forty-eight (48) Acts.
- ➤ Following important legislation were passed during the year 2017-2018:

- ➤ Thirty-five (35) Resolutions were passed by the National Assembly during the period and sixteen (16) Reports were laid in the National Assembly.
 - Three hundred and six (306) calling attention notices were received, out of which one hundred and two (102) were taken up in the House.

 Ninety two (92) adjournment motions were received by the National Assembly Secretariat and eight (08) were brought before the House.

 Thirty six (36) privilege motions were made and seven (07) were brought before the House. Six thousand eight hundred and sixty two (6862) questions were asked, out of which one thousand four hundred and thirty eight (1438) questions were answered.

➤ On 1stJune, 2017, the President of the Islamic Republic of Pakistan addressed the Parliament (Joint Sitting) to meet the constitutional requirement under Article 56 (3) of the Constitution of Islamic Republic of Pakistan.

3.2 **Senate Related Activities:**

3.2.1 Constitutional Provisions

- The President is empowered to summon either House or both Houses of Majlis-e-Shoora (Parliament) in joint sitting to meet at such time and place as he thinks fit and also to prorogue the same.

 Article 54 (1)
- Senate shall meet for not less than one hundred and ten (110) working days in each Parliamentary Year.
 Article 54 (2)

3.2.2 <u>Performance</u>:

Following are the main activities performed; details are attached as

Annexure-II.

- The Ministry of Parliamentary Affairs, keeping in view the requirements of mandatory working days and availability of Government business provided by Ministries/ Divisions /Departments, prepared a tentative schedule of sessions of Senate, and got approval of the Prime Minister for the period from 12th March 2017 to 11th March 2018.
- The summaries for summoning of Senate session initiated strictly in accordance with approved schedule during the Parliamentary Year.

 However, certain deviations were made depending on the exigencies of political and administrative factors
- ➤ In the reporting period, the Senate met in sixteen (16) sessions spread over one hundred and nineteen (119) working days.
- ➤ Seventy-eight (78) Orders of the Day in the year, 2017-2018 were issued for introduction and passage of Government legislative business in the Senate.
- ➤ Ten (10) Government Bills/Ordinances were introduced in the Senate.
- > Twenty-five (25) Government Bills were passed by the Senate.

- In compliance with Article 73 of the Constitution, the Finance Minister presented the Finance Bill, 2018, in the Senate for its recommendations thereon. The Senate extensively discussed the Bill and made one hundred and fifty-six (156) recommendations for consideration of the National Assembly. The Senate also submitted its recommendations to National Assembly on other four Money Bills.
- Twenty-two (22) Private Members' Bills were passed by the Senate.
- ➤ Two hundred seventeen (217) Call Attention Notices were received in the Senate, two hundred and five (205) Adjournment Motions were received and one hundred and eight (108) Privilege Motions were received.
- ➤ Sixty-three (63) Resolutions on different subjects were passed during the financial year, 2017-2018.
- Fourteen (14) Reports on various issues were laid in the Senate..
- ➤ Following three Bills have been passed by the Senate pertaining to the Election Commission of Pakistan.

- This Ministry appoints from amongst the Members of National Assembly with the approval of the Prime Minister. During the previous regime, thirty-four (34) Parliamentary Secretaries have been appointed.
- ➤ In pursuance of Rule 3(3) item 28(6) of Schedule –II of the Rules of Business, 1973, this Ministry, with the approval of the Federal Cabinet,

granted Ad-Hoc Relief Allowance -2017 @ 10 % on revised pay scales and enhanced daily allowance of the Members of Parliament including Parliamentary Secretaries and Chairmen Standing Committee, 2018.

3.3 Committee Related Activities:

3.3.1 <u>Performance:</u>

Nineteen (19) meetings of the Senate Standing Committee were conducted and accordingly coordinated during the said period, details of which are as under:-

➤ Nineteen (19) Court cases, pertaining to Election Commission of Pakistan (ECP) were also received from Supreme Court, High Courts etc. The same were persuaded in the courts in consultation with the Election Commission of Pakistan and M/o Law and Justice Division.

4 Prime Minister's Public Affair and Grievances Wing

4.1 <u>Objective of the Wing:</u>

The aim of Prime Minister's Public Affairs and Grievances Wing is:

"To provide relief to the general public particularly the poor of the poorest by redressing their grievances addressed to the Prime Minister".

4.2 <u>Nature of Grievances/Complaints:</u>

Such grievances mainly pertain to financial assistance, medical treatment, district administrations, police departments, utility services, procedural family disputes etc.

4.3 Progress/Achievements during the Year 2017-2018:

During the period under review, this Wing has succeeded to achieve the following:

- This Wing has processed as many as 22410 applications / complaints received from different corners of the country, out of which 15452 were disposed off, while rest of them 6958 applications / petitions are under process with various Government Ministries/ Departments / agencies at provincial as well as federal level (Annexure-III).
- As compared to the previous years, response level has improved up to 69%.
- The Minister-In-charge and Secretary, Prime Minister's Public Affairs and Grievances Wing conducted visits to IG Offices, Chief Secretaries, DCOs in different provinces to get the on ground situation of the progress and met the aggrieved persons.
- ➤ Software on "Complaint Handling System" was enforced, which provided online access to the Ministries / Departments / other agencies in order to

- ensure proper monitoring and evaluation of disposal of public complaints / applications.
- ➤ The Prime Minister's Grievances Wing arranged bone marrow transplant, liver transplant, cancer treatment and treatment for other fatal diseases. Since the beginning of this program till the end of the period under review as many as 624 patients have been provided treatment under PM's Fatal Disease Programme. (Annexure-III).
- ➤ The ear transplant service was also provided to many deaf children, which resolved their hearing issues.
- ➤ Prime Minister's Grievances Wing is collaborating with Medical Directorate of Adjutant Branch of GHQ, which envisages improvement of existing health facilities and setting up of new health institutions to enhance health coverage to the poor people of the country.
