



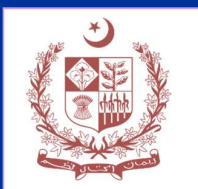

III. Introduction

Ministry of Parliamentary Affairs was re-established in April, 2012. Subsequently, the Prime Minister's Public Affairs and Grievances Wing was also transferred to this Ministry by Prime Minister's Office in June, 2013.



The Ministry primarily deals with the business of the Federal Government in Parliament and supervises the entire legislative process from introduction of bills to their assent by the President for enactments, summoning and prorogation of both the Houses of the Parliament including joint setting, follow up of Government Assurances given in the floor of either House, legislation pertaining to members of Parliaments, Elections & Election Commission of Pakistan and matters regarding rules of procedures and conduct of business in both the Houses. It plays an important role in coordinating and maintaining liaison amongst different organs of the State with objective of ensuring harmonious functions of the polity. Moreover, the Ministry also facilitate in redressing grievances of the common people through its Prime Minister's Public Affairs and Grievances Wing (PA & GW).

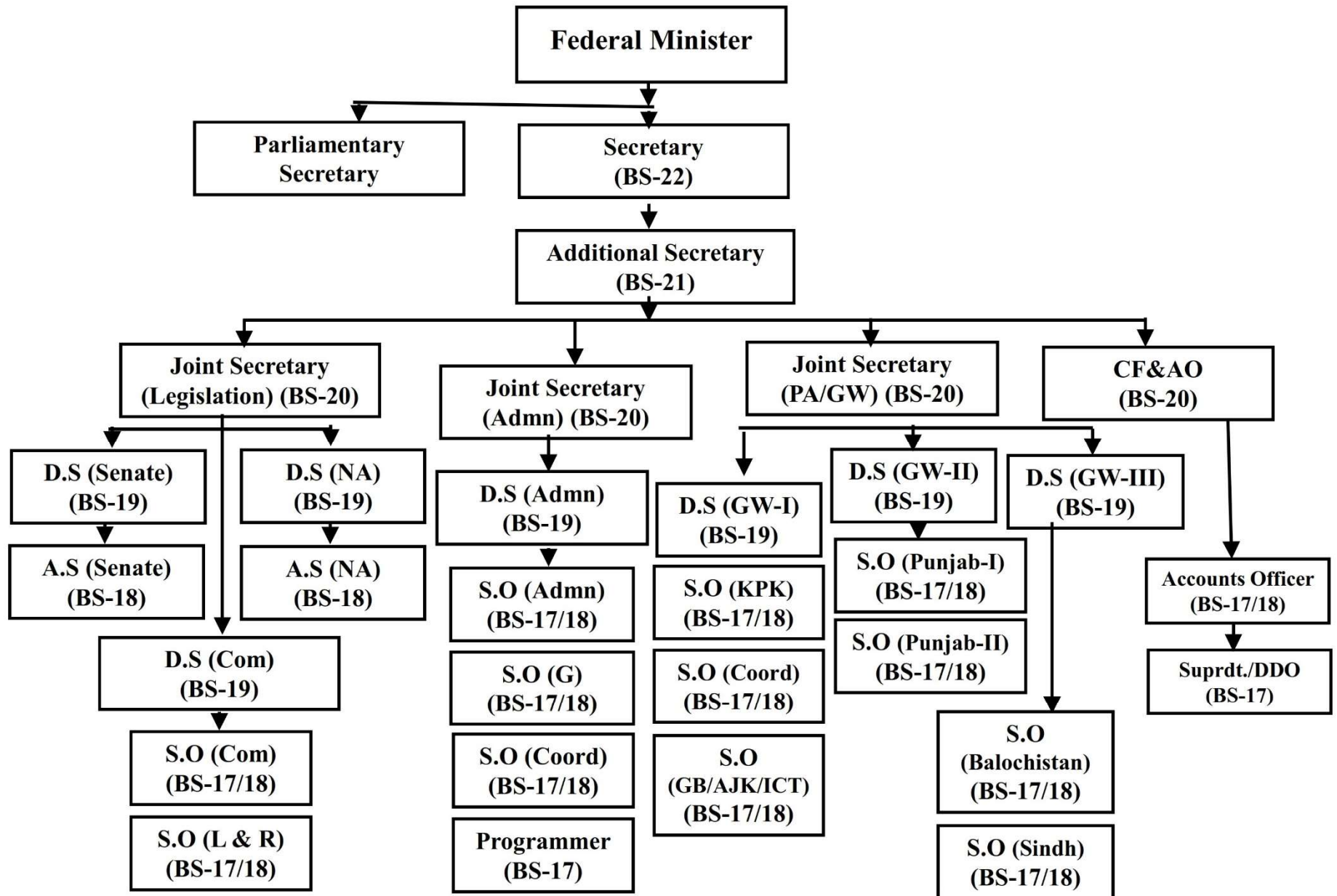

IV. Functions of the Ministry of Parliamentary Affairs as per Rules of Business, 1973

Following functions have been assigned to the Ministry of Parliamentary Affairs under Rules of Business, 1973:-

- Summoning of either House or both Houses or Joint Sitting of Majlis-e-Shoora (Parliament) and prorogation thereof.
- Dissolution of the National Assembly.
- Liaison between the Divisions and Majlis-e-Shoora (Parliament) in respect of official and non-official business with priority of official business.
- Follow up of the assurances, promises and undertakings given by the Federal Government on the floor of the House with a view to their implementation by the Division concerned.
- Submission of Bills passed by Majlis-e-Shoora (Parliament) or by the National Assembly to the President for his assent.
- Legislation pertaining to privileges of Chairman of the Senate, Speaker and Deputy Speaker of the National Assembly and members of Majlis-e-Shoora (Parliament).
- Legislation pertaining to the Leader of the House and the leader of the Opposition.
- Rules of Procedure of either House or Joint Sitting of Majlis-e-Shoora (Parliament).
- Legislation pertaining to punishment of persons who refuse to give evidence or produce documents before committees of National Assembly or the Senate.
- Appointment and terms and conditions of Federal Parliamentary Secretaries.
- Legislative business relating to the Election Commission of Pakistan.
- Prime Minister's Public Affairs and Grievances Wing.

HUMAN RESOURCE MANAGEMENT OF THE MINISTRY

i. Legislation Wing:

- Summoning and prorogation of sessions of National Assembly, Senate and the Joint Sitting
- Liaison between Federal Government and the Parliament on parliamentary business.
- Legislation pertaining to official and non-official bills in the National Assembly and Senate
- Legislation regarding salaries and allowances of the following:-
 - Members of Parliament (Senators and MNAs)
 - Speaker National Assembly and Chairman Senate
 - Deputy Speaker National Assembly and Deputy Chairman Senate.
- Coordinating/ Assisting meetings of six (06) Standing Committees of National Assembly and Senate viz; Standing Committees on Rules of Procedures and Privileges, Committee on Government Assurances and Standing Committees of Parliamentary Affairs and of both the Houses.
- Appointment and terms and conditions (including pay and allowances) of Parliamentary Secretaries.
- Follow-up of assurances
- Submission of bills passed by the Parliament for the assent of the President.
- Processing appointments of Chief Election Commissioner, Member Election Commission,
- Legislation pertaining to Election Laws.

ii. Public Affairs and Grievances Wing:

- All matters relating to petitions/ complaints received from aggrieved persons from all over the country, AJK, GB as well as overseas Pakistanis.

iii. Administration Wing:

- All aspects related to Human Resource Management of the Ministry including:-
 - Staffing
 - Trainings
 - Promotions
 - Advances
 - Court cases
 - Retirements
 - PERs
 - Disciplinary proceedings
 - Financial and budgetary allocations/ expenditures.

1. Legislation Wing

1.1 Sessions of the Parliament:

In terms of Article 54 (1) of the Constitution, the President summons either House or both Houses or Majlis-e-Shoora (Parliament) in joint sitting to meet at such time and place as he thinks fit and also prorogues the same.

Article 54 (2) read with Article 61 of the Constitution provides that the National Assembly and the Senate shall meet for not less than 130 and 110 working days respectively in each Parliamentary Year. However, the Speaker or the Chairman Senate, as the case may be, may also summon the respective House on a requisition sign by not less than one fourth of total membership.

During the financial year (from 01-07-2021 to 30-06-2022) the National Assembly and Senate met for 150 and 134 days respectively. The parliamentary year of the incumbent National Assembly and the Senate commence respectively on 12th August, and 12th March every year.

1.2. Annual Calendar for Sessions

In order to meet the obligatory sessions under the provisions of the Constitution and facilitating the parliamentarians to plain visits for their respective constituencies, annual calendars for the sessions of both the Houses are prepared at the start of each parliamentary year. These calendars are accordingly circulated among members under the provisions of rules of procedures and conduct of business of both the Houses. The provisions of rule-46 of the Assembly Rules and rule 21 of the Senate Rules relate to the annual calendar of the respective Houses. The calendars also help the cabinet members to plan their official engagements keeping in view the sessions of the Parliament so as to accord priority to the parliamentary business.

1.3. Orders of the Day

The orders of the day for the sessions of both the Houses are prepared by the respective secretariat for each sitting and make a copy thereof circulated to each member and any other person entitled under the Constitution to speak or take part in the proceedings of the Parliament. The business of the orders of the day for the National Assembly or the Senate, is classified as (a) Government Business and (b) Private Member Business. The respective secretariat arranges the government business in the order of the day as intimated by Ministry of Parliamentary Affairs.

Moreover, the provisions of Rules of Business, 1973 stipulate that Secretary Parliamentary Affairs shall in consultation with the appropriate leader of the House, prepare orders of the day for each official day and forward it to the appropriate Secretariat. In the case of the Joint Sitting the orders of the day shall be prepared in consultation with the Prime Minister and forwarded to the Secretary of the Assembly.

Ministry of Parliamentary Affairs issued agenda for seventy-nine (79) Orders of the Day of the NA to transact government business viz: official bills, statutory reports to be laid, motions etc. under rule 52 of the Rules of Procedure and Conduct of Business in the National Assembly, 2007. The N.A met for 150 days during the year 2021-22 against mandatory requirement of 130 days Calendar of the National Assembly's sessions for the fourth parliamentary year 13th August, 2021 to 12th August, 2022 is at **Appendix-I**.

Similarly, forty (40) agenda items of the senate were issued during the year to transact government business under rule 26 of the Rules of Procedure and Conduct of Business in the Senate, 2012. The Senate has met for 134 days during the year 2021-22 against mandatory requirement of 110 days Calendar of sessions of the Senate for the parliamentary year 2021-2022 (12th March, 2021 to 11th March, 2022) is at **Annex-II**. 1.4 Gist of Important Legislation Passed

S.No.	Name of the Act	Objects
1.	The Enforcement of Women's Property Rights (Amendment) Act, 2021	Women were not given right of inheritance on many pretexts. According to this law a woman can file a complaint before the Ombudsman who will ensure that she has the right of inheritance through the respective Deputy Commissioner. It gives a right of representation to the aggrieved party against the decision of Ombudsman, to be made before the President of Pakistan.
2.	The Mutual Legal Assistance (Criminal Matters) (Amendment) Act, 2021	International cooperation in criminal matters through mutual legal assistance is intended to bridge existing gaps in respective countries towards effective law enforcement. The requested state will provide legal support to the requesting state by executing necessary actions on its territory in criminal cases warranting shared assistance.
3.	The Protection of Journalists and Media Professional Act, 2021	To promote, protect and effectively ensure the independence, impartiality, safety and freedom of expression of journalists and media professionals.
4.	The International Court of Justice (Review and Reconsideration) ACT, 2021	The Bill is aimed to provide mechanism for review and reconsideration of Pakistan's own choice, to be provided to convicts like Jadhav.
5.	The Islamabad Capital Territory Charities Registration, Regulation Facilitation ACT, 2021	To make effective provisions for registration, administration, regulation and facilitation of the charities for the purpose of human uplift. To ensure that Charities may not be misused in any illegal activities like terrorism etc.
6.	The SBP Banking Services Corporation (Amendment) ACT, 2021	To enable the SBP Banking Services Corporation (SBP BSC) to optimize its operational efficiency thereby bringing it in conformity with the emerging operational needs.
7.	The Anti-Rape (Investigation & Trial) ACT, 2021	To ensure expeditious redressal of rape and sexual abuse crimes in respect of women and children through special investigation teams and special Courts providing for efficacious procedures, speedy trial, evidence and matters connected therewith or incidental thereto.
8.	The Corporate Restructuring Companies (Amendment) ACT, 2021	To achieve govt objective of reviving the distressed economic assets of the country and enable Corporate Restructuring Companies (CRCs) to reach compromise with the distressed entities promptly.
9.	The Financial Institutions (Secured Transactions) (Amendment) ACT, 2021	To bring the existing legal framework in line with international best practices for secured transactions laws besides ensuring efficient functioning of the Secured Transactions Registry established under the Act and Government's objective to promote access to finance for small businesses and improve global rankings in order to create positive image of the country internationally.

The Companies (Amendment) ACT, 2021	to ensure compliance with FATF's recommendation aimed at enhancing the transparency of legal persons, to fulfill the recommended actions in Mutual Evaluation Report, and to enhance the country's ranking and to conform to the action plan approved by the National Executive Committee on AMUCFT for compliance with the FATF recommendations
11.	The National Commission on the Rights of Child (Amendment) Act, 2022	To provide clarity with respect to exercise of authority by the Federation in pursuant to the directions of the Cabinet in light of the recent Supreme Court Judgment (PLD 2016 SC 808)
12.	The Islamabad Capital Territory Child Protection (Amendment) Act, 2022	To provide clarity with respect to exercise of authority by the Federation in pursuant to the directions of the Cabinet in light of the recent Supreme Court Judgment (PLD 2016 SC 808)
13.	The Juvenile Justice System (Amendment) Act, 2022	To provide clarity with respect to exercise of authority by the Federation in pursuant to the directions of the Cabinet in light of the recent Supreme Court Judgment (PLD 2016 SC 808)
14.	The Protection against Harassment of women at the Workplace (Amendment) Act 2022.	To facilitate increased participation of women in workforce by removing lacuna present in the existing law. 15.	The State Bank of Pakistan (Amendment) Act, 2022	To provide clarity about the objectives of the Bank, enhance its autonomy and thereby strengthen accountability. To abolish Monetary and Fiscal Policies Coordination Board.

1.5. Resolutions Adopted and Reports Presented:

"Resolution" means a motion for the purpose of discussing and expressing an opinion on a matter of general public interest and includes a resolution specified in the Constitution. The Ministries / Division concerns, after having received a copy of resolution from the respective Secretariat of the Parliament, are required to apprise the National Assembly with in a period of six months or as the case may be to the Senate within a period of two months, about the action taken on the resolution.

A part from reports to be laid in the Parliament under the provision of the Constitution, as also recognized in the rules of procedures and conduct of business on both the Houses, the statutory report under the provisions of different Acts are also laid in both the Houses. The resolutions adopted and reports laid during the year 2021-22 in the National Assembly and Senate are as under:-

1.6. Calling Attention Notices:

A member may, after question of privilege and adjournment motion, if any, with the previous permission of the Speaker or the Chairman Senate, call the attention of a Minister to any matter of urgent public importance and the Minister may make a brief statement or ask for time to make a statement at a later hour or date. During the period under report the number of calling attention notices in the National Assembly and Senate are as under:-

1.7 Adjournment Motions:

Normally, no business not included in the order of the day can be transacted at any sitting without the permission of the Speaker or the Chairman Senate as the case may be. However, a matter of public importance can be raised by interrupting the regular business of the House through an adjournment motion tabled at the earliest opportunity, if the Chair gives his consent thereto. By moving the adjournment motion, members try to impress upon the Presiding Officer that their concern regarding a particular issue, justifies that the respective House may adjourn or stop its normal working and consider the matter which is being raised. During the period under report the adjournment motions as per the details given below has been issued in the National Assembly and Senate.

1.8 Privilege Motions:

The terms privilege applies to certain rights and immunities enjoyed by each house of Parliament and Committees of each house collectively and by members of each house individually. Any member from either House can move a notice in the form of a motion against the member who he/she thinks is guilty of the breach of privilege. During the period under report the Privilege motions as per the details given below has been issued in the National Assembly and Senate.

1.9. Joint Sitting

Under article 54(1) of the Constitution, the President may, from time to time, summon either House or both Houses or 2 [Majlis-e-Shoora (Parliament)] in joint sitting to meet at such time and place as he thinks fit and may also prorogue the same. In addition to summoning joint sitting of the Parliament for legislation under Article 70(3) of the Constitution, at the commencement of the first session after each general election to the National Assembly and at the commencement of the first session of each parliamentary year, both the Houses are assembled together for Presidential address, under Article 56(3) of the Constitution. On 13th September 2021, the President of the Islamic Republic of Pakistan addressed the Parliament (assembled together) to meet the constitutional requirement. During the period under report the Parliament met in joint sitting for seven (07) *days*.

1.10 Parliamentary Secretaries

All the matters relating to Parliamentary Secretaries viz; their appointments, terms & conditions and salaries/allowances, etc. are managed by this Wing. Details may be seen on the Ministry's website.

1.11 Committees of the Parliament

Parliament transacts a great deal of its business through Committees, which are considered as extension of the respective House. In addition to the Bills introduced and referred to Standing Committee concerned, a House may remit any matter to the concerned Committee, under the provisions of the Rules framed by both the Houses. A Committee may examine the expenditure, administration, delegated legislation, public petition and policies of the Ministry concerned and its associated public bodies. Committees also have powers vested in civil court under the Code of Civil Procedure, 1908 to take evidence or call for papers, record or documents.

Matters pertaining to following three Committees of Senate and National Assembly, are dealt by this Ministry and Minister for Parliamentary Affairs represents the Federal Government as ex-officio Member to these Committees.

i. Standing Committee on Parliamentary Affairs:

There is a Standing Committee of each Ministry in the National Assembly and the Senate. Standing Committee on Parliamentary Affairs of both the Houses deals with the subjects assigned to this Ministry under Rules of Business 1973, framed by Federal Government or any other matter referred to it by the Parliament.

ii. Committee on Rules of Procedure & Privileges:

The Committee considers matters of procedure and conduct of business in the National Assembly or in the Senate and recommends such amendments to these procedures/rules as may be deemed necessary. It also examines every question of privilege referred to it by the respective House and determines with reference to the facts of each case whether a breach of privilege is involved and, if so, the nature of the breach and the circumstances leading to it; and makes such recommendations as it may deem fit. The Committee also suggests the procedure to be followed by the respective House to give effect to its recommendations.

iii. Committee on Government Assurances:

The function of the Committee on Government Assurances is to take note of the assurances, promises, commitments, and undertakings of the Government given by its Ministers from time to time on floor of the respective House and to regularly report on the extent to which such assurances and promises have been implemented, and whether the implementation has taken place in a timely and effective manner. 1.13 Election Commission of Pakistan

In addition to Elections law, other matters relating to ECP are also dealt by this Ministry including appointment of Chief Election Commissioner (CEC) and Members, approaching the Parliament for transaction of its parliamentary business etc. CEC or Members of ECP are appointed by the President on the recommendations/confirmation of Parliamentary Committee constituted by the Speaker National Assembly under Articles 213 and 218 of the Constitution, from the panels submitted by the Prime Minister and Leader of Opposition in National Assembly. Following members of ECP were appointed during the period under report;

- Mr. Babar Hassan Bharwana from Punjab and;
- Mr. Ikram Ullah Khan from Khyber Pakhtunkhwa

**2. Prime Minister's
Public Affairs
And Grievances Wing**

2.1 PM's PA & Grievances Wing.

- The Wing was shifted to Ministry of Parliamentary Affairs in 2013. It processes public complaints pertaining to financial assistance, mal administrative practices, infrastructure, municipal services, public property issues across the country including GB, AJK and overseas Pakistanis. The complaints received in the wing are properly scrutinized and categorized as actionable and non-actionable in the accordance with a prescribed criterion devised by the office of the Prime Minister. The complaints after scrutiny are forwarded to the concerned ministries / divisions, Federal / provincial departments for redressal through Pakistan Citizen's Portal (PCP). The concerned authorities used to dispose of the cases within the stipulated period (20-40 days) and forward the requisite replies to this wing through PCP. The wing used to keep in touch and pursue the cases with the complaint to know their satisfaction level. In case of dissatisfaction, the petitioner may be reopened for reconsideration on the written request of the complainant.
- The complainant is supposed to follow the below mandatory instructions.
 - i. Complaints is required to be addressed to the Prime Minister of Pakistan duly signed by the complainants.
 - ii. Valid CNIC and mobile number are to be shared.

Prime Minister's Public Affairs and Grievances Wing of this Ministry receives manual complaints of public from all over Pakistan and tries to address the grievances in a friendly and timely manner. Such grievances mainly pertain to land revenue, law and order, human rights, basic services, etc. relating to Federal, Provincial Governments and attached departments of Government of Pakistan.

The Wing received 21096 petitions/ complaints, out of which 20461 were disposed of, while 635 petitions/ complaints are under process with various Government Ministries/ Departments/ Agencies at federal as well as provincial level. The breakup of these complaints is as under: -
